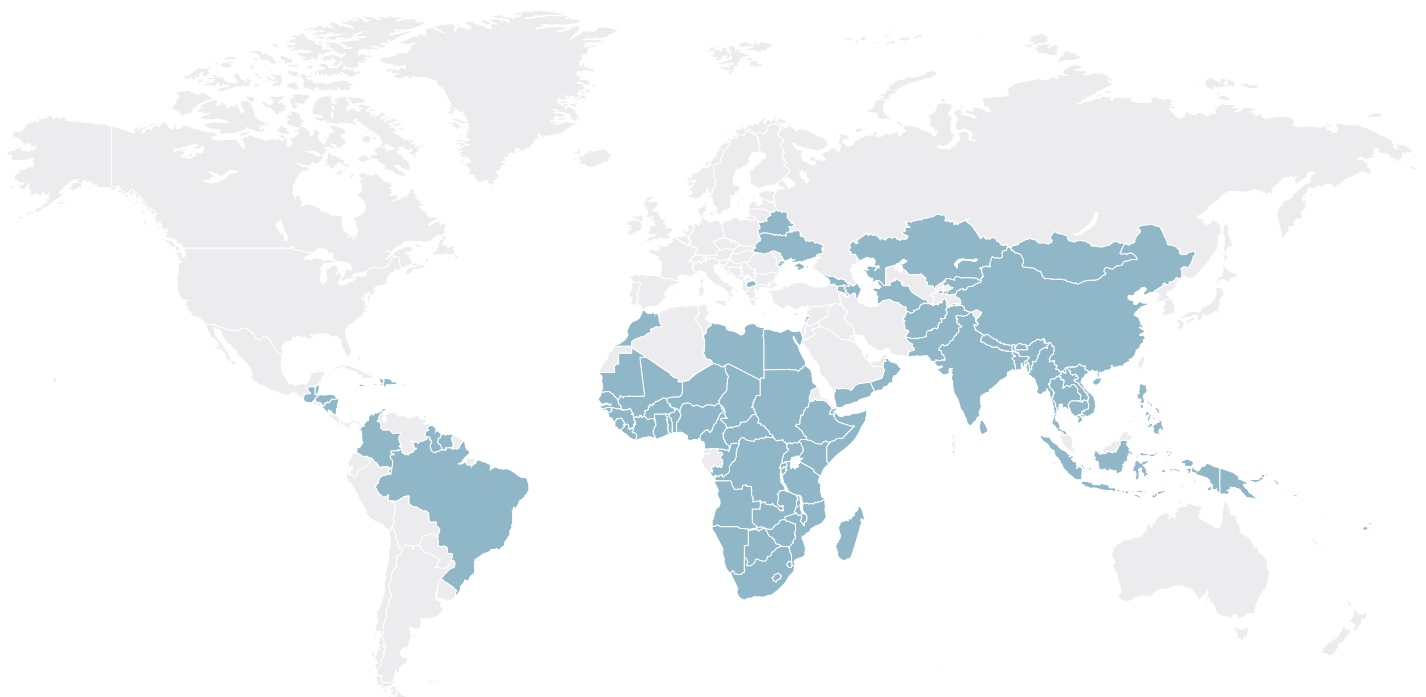
Our Mission
